INFORMATION AUTHORISING THE VOTING RIGHTS PROXY HODERS OF JOST WERKE AG

You can authorize the voting rights proxy holders designated by JOST Werke AG, Mr. Björn Michel and Mr. Markus Laue, employees of Link Market Services GmbH, business address Munich, Germany, who can each vote on your behalf on their own and are bound by your instructions. The voting rights proxy holders are entitled to vote on your behalf only if you have given them specific instructions regarding the individual motions proposed for the items on the agenda. The voting rights proxy holders must follow your instructions when voting on the motions proposed as announced in the agenda.

Electronic exercising of voting rights (electronic postal vote) or electronic issuing of power of attorney and instructions to JOST Werke AG's voting rights proxy holders

You can also exercise your voting rights electronically (electronic postal vote), i.e. via the password-protected Annual General Meeting portal of the Company at http://ir.jost-world.com/agm. In this way, the electronic issuing of power of attorney and instructions to JOST Werke AG's voting rights proxy holders is possible. To do so, you must log in with your personal access data in the password-protected Annual General Meeting portal of the company at http://ir.jost-world.com/agm and exercise your voting rights or authorize the voting rights proxy holders designated by the Company to exercise your voting rights in accordance with your instructions.

Important information:

Please note that only shareholders entitled to participate and vote who are properly registered are entitled to cast their votes by electronic postal vote or to issue electronic and written power of attorney to the Company's voting rights proxy holders and to issue instructions for exercising their voting right to the voting rights proxy holders designated by JOST Werke AG. The written issue of power of attorney and instructions to the voting rights proxy holders designated by JOST Werke AG is possible **until May 4, 2022, 12:00 h (CEST)** (receipt by the Company). Therefore please fill in and send this form until the aforesaid date to the Company. The electronic postal vote or the electronic issuing of power of attorney and instructions to the voting rights proxy holders designated by JOST Werke AG is possible via the Company's password-protected Annual General Meeting portal at http://ir.jost-world.com/agm even on the day of the Annual General Meeting up until the opportunity to exercise the voting rights is formally ended by the chairman of the meeting.

If divergent explanations are received on different channels and it is not clear which one was last submitted, they will be considered in the following order: 1. by Annual General Meeting portal, 2. by e-mail, 3. by regular mail.

If instructions are not properly filled out or not clearly given, the Company's voting rights proxy holders, depending on the voting procedure, will either abstain or not participate in the voting for the respective agenda items. You cannot instruct the voting rights proxy holders of JOST Werke AG to raise an objection, file a motion or ask questions.
